

JURIST DAY- ART OF DRAFTING A CONTRACT

Gitarattan International Business School, Delhi, Centre for Legal Studies, organized Jurist Day on “Art of Drafting a Contract” on 30th November 2022 from 10:00 am to 12:00 noon at the Auditorium. The session was intended to inculcate drafting skills among the students and to make them understand the essentials of a valid contract. The resource person for the session was Hon’ble justice Sh. Ved Prakash Vaish, High Court of Lucknow.



The session began with the felicitation of the guest speaker Hon'ble Justice Ved Prakash Vaish, High Court of Lucknow, with the sapling by Hon'ble Director Prof. P.M Johari. Hon'ble Justice Ved Prakash Vaish started the session by discussing the various essentials of a valid agreement, offer, acceptance, lawful consideration, lawful object, etc. He also explained about the distinction between void and voidable agreement. He then explained the capacity to contract thereby explaining the position of a minor's agreement. After delving into the essentials of a valid agreement, sir then explained the process of drafting a contract. He emphasized on the use of simpler language and how caution needs to be taken while using words like, thereby, hereafter, henceforth, etc. He also highlighted the importance of using gender neutral terms while drafting a contract, e.g. Chairperson instead of chairman. He laid stress on use of proper grammar and active voice while drafting a contract.

Hon'ble Director Sir Dr. P.M. Johri graced the event with their presence and enlightened the students about the same. The session was very interactive and enlightening, number of students participated in it. Their queries were also resolved by the exchange of views. The session was a very fruitful one. Total 214 students of BA LLB and BBA LLB 1st semester attended the session. Jurist Day on "Art of Drafting a Contract" was concluded by a vote of thanks by Hon'ble Director Sir Dr. P.M. Johri and by giving a memento as a token of appreciation to our esteemed guest for his time and valuable input that he shared with us.
