

The coordinator welcomed the members to the meeting and introduced the newly added member. The house welcomed newly joined member. Coordinator initiated the discussion on academics, Examination & Evaluation, co-curricular and extracurricular activities, informing the resolution taken in the last meeting and the house approved the same.

**Item No.1: Orientation Capsule-BBA Sem 1**

- a. The Orientation Capsule for BBA semester 1 was organised from 1<sup>st</sup> to 8<sup>th</sup> December, 2021. The programme started with Orientation briefing and presentation by HOD BBA Prof Anup Ghosh to familiarize the students to an unknown campus environment, its faculties and infrastructure. The orientation programme was essential for the students to understand the environment, rules, and procedures of GIBS related to various parameters.
- b. Prof Anup informed that institute conducted many co-curricular and extracurricular activities in a week long capsule programme like Games on Innovation & Creativity,

Leadership and Management Games, Communication Basics, Maths Basics, Accountancy Basics, Application of IT in Business. Activities like self-defense for girls, Fit India movement (Marshall arts) and many more activities by Mudra, Heritage, Abhinay and Lakshaya club were also conducted during these days.

- c. He further informed that the resource person for the Fit India movement session: self-defense for girls was Ms. Kiran Uniyal. She is Black Belt Dan 3 and Krav Maga Instructor. Ma'am is the first woman to achieve the greatest number of World Records in Martial Arts in India. She has achieved 18 world records in Martial Arts Fitness and Social Service, 12 world records including 11 Guinness World Records in Martial Arts. Ms. Uniyal was accompanied by Mr. Ankamma Rao Pola, Black Belt Dan 1, ultra-marathon runner and marathon runner, Guinness world record holder, who has won 3 gold, 2 silver and 3 bronze in Taekwondo Championships including National Level.
- d. The house appreciated the initiative of institute to carry such a capsule course which was mix of academics and extra-curricular activities.

**Item No 2: Work from Home**

Ms. Prachi Jindal informed the house that with reference to the Order No: F.60/DDMA/COVID-19/2021/509 dated 11-1-2022, Government of NCT Delhi had imposed restrictions to contain the spread of COVID-19 virus, including the highly contagious and transmissible Omicron variant therefore all the faculty and staff members were required to perform their duties as 'Work from Home' w.e.f. 12.01.2022. Faculty and Staff members who were associated to Administration/Examination duties and IT related duties for smooth conduct of online Classes were only required to attend the Institute against special passes. This step was taken to ensure the safety of staff members.

**Item No.3: Dissemination of Internal Assessment Policy to Semester 1 students**

Prof Anup Ghosh informed the house about the circulation of internal assessment policy among the students of all programmes of semester 1 through student notice. The students were informed that internal assessment of 25 marks will be undertaken as Continuous evaluation of each unit on the basis of MCQ, Assessment of Classroom Activities and Minor Examination comprising of weightage of 5, 5 and 15 marks respectively.

**Item No. 4: Allotment of Programme Coordinators & Class Coordinators for the Academic Session 2021-2022**

Prof BK Yadav informed that the allotment of Programme Coordinators & Class Coordinators was done for the Academic Session 2021-22 and the notice was out on 13<sup>th</sup> January, 2022. Prof Uma Gulati took a session to elucidate the duties and responsibilities of class coordinators and programme coordinators so that there is clarification in performing the same. The functions of Programme Level Committee (PLC) have been stressed by Dr Sonia Jindal.

**Item No.5: Course plan presentation for Even Semesters Academic Session 2021-22**

Prof Anup Ghosh informed about the course plan presentation held from 18<sup>th</sup> to 21<sup>st</sup> January 2022 for MBA, MBA (IB) Sem 4, BBA Sem 4 & 6, LLB Sem 4 LLB Sem 6 and LLB Sem 8. Faculty members of said programmes presented the course plan of their allocated subject. Programme Level Committee present during presentation suggested changes wherever required and informed faculty members to submit the modified course plan by 22<sup>nd</sup> January, 2022.

Prof. Anup Ghosh, Prof Uma Gulati and Prof BK Yadav informed that all modified course plans were received by the stipulated time for their respective programmes. The report of all PLC has been submitted before the committee and all the recommendations of PLC have been accepted by IQAC.

**Item No.6: Commencement of Classes for Even Semester, Academic Session 2021-22**

- a. Prof Uma Gulati informed that the classes for MBA MBA (IB) semester 4, BBA semester 4 & 6 and BALLB and BBALLB semester 4, 6 & 8 started in online mode from 24<sup>th</sup> January, 2022. She apprised the house that all arrangement related to same were completed well on time and dissemination of time table was done to all concerned faculty members as well as students.
- b. She further informed that The Delhi Disaster Management Authority (DDMA) has announced the reopening of colleges in offline mode owing to the drop in corona virus cases. Considering the notification of DDMA, the Institute decided to begin with classes in complete OFFLINE mode with effect from 14<sup>th</sup> February, 2022 for MBA & MBA (IB) Semester 4, BBA (Semester 4&6) and BALLLB & BBALLB (Semester 4, 6 & 8).

- c. It was also informed that the classes for MBA, MBA IB, BBA, BALLB & BBALLB semester 1 will continue in Online Mode as their syllabus is on the verge of completion and will resume in physical mode from 2<sup>nd</sup> Semester. The dates for commencement of classes for 2<sup>nd</sup> Semester will be announced in due course of time.
- d. The Institute started offline classes for even semesters of all programmes from 14<sup>th</sup> February, 2022 and all classes are going on smoothly in offline mode.
- e. The Institute adopted a set of Standard Operating Procedures (SoPs) in consonance with the directions/guidelines issued by the DDMA. The SOP were released to orient all employees and students of GIBS to observe self-discipline in adopting COVID responsible behavior at all times and under all circumstances for the offline classes and specific precautionary measures to be adopted by all members of GIBS. This SOP covered all stakeholders working, studying and visiting the institute, Campus. The aim was to create ways and measures that would ensure that the work environment is safe.

**Item No.7: Project Dissertation MBA, MBA (International Business) & BBA**

- a. Prof Uma Gulati and Prof Anup Ghosh informed the house about the project dissertation of MBA, MBA (International Business) Sem 4 and BBA Sem 6 respectively. Prof Uma informed that each faculty member has been assigned a certain number of students to guide them in their project work. Faculty members are suggested to prepare appropriate number of titles and allocate to the students assigned to them. In MBA and MBA (IB) programme, the project coordinators have been appointed as per specialization. To make student understand about the process and guidelines to conduct the project work including its methodology & phase wise evaluation, project briefing was scheduled on 27<sup>th</sup> January, 2022.
- b. Prof Anup K Ghosh informed that in BBA also faculty guides have been appointed section wise and project briefing has been carried by Dr Sheetal. She explained the procedure and guidelines to carry the project work along with phase wise evaluation.
- c. Dr Sonia Jindal appreciated the efforts of faculty members in carrying the research work systematically. She also stressed upon the fact that research problems should be identified from industry point of view which can be connected afterward with their solutions.

Prof Uma Gulati informed that meetings of different statutory committees were held in December 2021 and minutes were recorded. She further informed that the minutes of Anti ragging committee, SC/ST cell, Internal Complaint Committee, Alumni Committee, Grievance Redressal Committee and Mentoring Counseling Cell were duly signed by members and were put on records in their respective registers.

**Item No 9: HR Conclave**

The HR Conclave entitled “Blended Learning- Its Impact on Multidimensional Skill Development and Ramifications’ was organized by Gitarattan International Business School on 4 December, 2021. Management students, faculty members and external participants attended the HR Conclave. The conclave was organized to comprehend the significance of blended teaching - learning in a dynamic world. The theme of the conclave was very well presented and explained by three eminent guest speakers, namely Mr. Rajiv Naithani, CVP and Chief People Officer- Infogain, Mr. Sanjeev Tripathi – Head HR India OSRAM and Mr. Vir Bharat, HR Head at Yamaha. Mr. Rajiv Naithani initiated the session and talked about the importance of communication in online learning. Mr. Sanjeev Tripathi shared his insights on the topic by presenting the application model of Blended Learning. In the concluding section Mr. Vir Bharat shared the methods and tools which can make Blended Learning effective and immersive.

**Item No 11: Moot Court Presentation Schedule**

**Item No. 13: -NSS Events**

- a. Ms. Prachi Jindal informed that Winter Clothes Donation Drive was organized by GIBS NSS Unit from 15<sup>th</sup> December 2021 till 21<sup>st</sup> December 2021. Cartons labelled 'Donation' were placed at the Canteen, Reception and Admin office 1<sup>st</sup> floor, in college premises where students, faculty and staff donated winter clothes, blankets, shoes etc. These items were distributed to the homeless children, adults and families living under the flyovers, on footpaths etc. by the volunteers of NSS Unit. Mr R K Jain appreciated the initiative taken by NSS unit of institute for such a noble cause.
- b. Ms. Prachi Jindal informed that the NSS Unit has organized a Fashion Show "Sanskriti" on 26th November 2021 depicting the costumes of different states and UTs of India along with celebration of Constitution Day of India. This programme was an initiative under Ek Bharat Shreshth Bharat Campaign launched by the Union Government of India. Both the speakers focused on the importance of 'Outcome Based Education' Session 2 was taken by Prof. Sandeep Srivastava, HOD, Dept. of HSS, Jaypee University of Engineering & Technology, Guna on 'New Education Policy 2020' Session 3 was taken by Prof. B. S. Pabla, Professor, Mechanical Engineering Department, National Institute of Technical Teachers Training and Research (NITTTR), Chandigarh. He gave an overview of NBA Approach and discussed its process and accreditation in details.

Prof. Kumar covered the topic ‘Learning Resources for Outcome Based Education’ during session-3.
- f. **Day 5:** Prof. Varaprasad G., Professor, BMS College of Engineering, Bangalore delivered session1 on ‘Outcome-Based Assessment Tools and Techniques’ Session-2 was also conducted by Prof. Varaprasad G., Professor, BMS College of Engineering, Bangalore on ‘Documentation for NBA’. The final session of the day was taken by Prof. (Dr.) Sreeram Sundar Chaulia, Dean, Jindal School of International Affairs (JSIA), O. P. Jindal University on ‘Diversity and Inclusion’
- g. **Day 6:** The session was conducted on stress management by Prof. (Dr.) Anup Ghosh, GIBS and Prof. (Dr.) Uma Gulati, GIBS. The Session 2 of the FDP programme was held to conduct the final test by Dr. Tanmay Pant, Assistant Professor GIBS. The test

- i. Prof Vikas informed that the programme was well received by participants. The house appreciated the efforts of institute in organizing the event professionally.

**Item No 15: Grammarly Software**

Ms. Prachi Jindal informed that the Institute has purchased the Grammarly software for ease of faculty membersto produce quality work concerning; JGIBS, GLJ, GIBS DIGEST, NEWSLETTER, EVENT REPORTS and any other document which requires a thorough proof reading.

**Item No. 16: Physical joining of all Teaching Staff members**

With reference to DDMA order vide dated 27.01.2022 and keeping in view the declining cases of Covid 19 in Delhi/NCR, Institute was re-opened for the physical joining of all Teaching Staff members w.e.f. 01<sup>st</sup> February 2022. Further, in view to ensure safety in the office and work places, all are required to follow the guidelines issued by central/state. It was also notified that if any faculty and staff member suspect the symptoms of Covid 19, they are required get themselves tested for Covid 19 and submit the RT PCR report to avail "Work from Home".

**Item No. 17: Introduction of MOOC in Syllabus by GGSIPU for MBA & MBA (IB)**

- a. Prof Uma Gulati informed about the introduction of MOOC in MBA and MBA (IB) semester 2 as per the revised syllabus of GGSIPU for Academic Session 2021-22. She further informed that a detailed session on same was organized for students to sensitize them on the MOOC as per GGSIPU curriculum.

- b. - c. Prof A S Ramnaraynan added that students were informed if they need any counseling on selection of MOOC course, they can contact MOOC coordinator. After registration in the course on swayam platform, student is required to fill the Form providing the details of the course selected.

**Item No.18: IIPC Orientation Day & Pre-Placement Talk On “Law & Corporate World”**

- a. Centre for legal Studies, Industry Institute & Partnership Cell (IIPC) and District Legal services Authority jointly organized an event ‘Orientation Day and Pre-Placement Talk’ for BALLB & BBALLB students. One hundred and thirty-five students participated in the event. The event was divided into two parts. The first part was about the introduction of IIPC. The students were informed about the roles and responsibilities undertaken by IIPC. The first session was conducted by faculty coordinators of the Placement Cell, Dr. Swati Srivastava, Assistant Professor, Law, and Ms. Shireen Singh, Assistant Professor, Law, GIBS. They made the law students aware of the policy framework of IIPC and the placement guidelines. The discussion also included drafting of impressive resume and tools to explore career opportunities.

- a. **Item No 30: Institute Innovation and Entrepreneurship Cell (IIC) Events**


