

WORKSHOP ON LEGAL DRAFTING 25th NOVEMBER, 2023 (SATURDAY)

A workshop on Legal Drafting was conducted by CLS-GIBS on 25th November 2023 by Dr. Abha Kulshreshtha, Advocate, Hon'ble High Court of Delhi. The objective of a workshop on legal drafting is to equip participants with the necessary skills and knowledge to draft clear, concise, and effective legal documents. Legal drafting is a crucial aspect of the legal profession, and a well-structured workshop helped the participants enhance their abilities in this area.

Dr. Abha Kulshreshtha Ma'am explained various aspects of Drafting such as Drafting of Will, Drafting of Agreements including Arbitration agreement, Trademark, Landlord Tenant Agreements, and Matrimonial Agreements. She explained about the Drafting of Will that anyone can be a party to be a will and only last dated will is very important and enforceable. Will is to be executed in the presence of witness, as if registration is mandatory or sometimes not applicable.

Various types of agreements, matrimonial agreements, arbitration agreement, partnership deed, and trademark and landlord tenant agreement were discussed. She gave assignments to the students on the aforementioned topics.

The main highlight of the event was badging ceremony of Office Bearers of Legal Aid Clinic. Sidak Singh Narula, BBA LLB Semester V was appointed as the President and Srishti Bansal, BA LLB Semester V as the Vice President of the Legal Aid Clinic.
