#### EVENTWISE RULES AND REGULATIONS

### BUSINESS PLAN COMPETITION

Max. Entries: 15

Team Size: 2-3 participants per team

Time Allotted: 10 min presentation (including 2 min Q& A)

#### **Rules:**

1. The team will present the Business Plan before the judges.

- 2. The Business Plan should preferably be made by using Business Model Canvas.
- 3. The Business Plan should have the following contents:
  - a. Executive Summary A brief on Business Plan (max word limit 200)
  - b. Company Description Proposed name and logo of the company
  - c. Market Analysis Segmentation, targeting and positioning of the product
  - d. Competitive Analysis Industry analysis
  - e. Marketing Plan Promotion and distribution strategies
  - f. Financial Projection Projections on ROI and funding plans etc
  - g. Prototype Graphical representation of the product/ service prototype.
- 4. Each team will be scored on the following criteria:
  - a. Prototype Development (10 marks)
  - b. Feasibility of Plan (10 marks)
  - c. Market attractiveness/ Growth Potential (10 marks)
  - d. Q & A Round (10 marks)

### **ADMATTAZ**

### THE ADVERTISING MAKING COMPETION

Max entries: 15

Team Size: 2-4 participants per team

Time Allotted: 60 min preparation time. 5 min presentation

1. Redesign a Print Advertisement of the product assigned to the individual.

- 2. All software are allowed for creating print advertisements. (eg. Canva)
- 3. Each Team will be given 60 mins preparation time.
- 4. Each team will be given 3-5 mins to explain/enact their advertisement.
- 5. Caution should be taken to refrain from displaying obscenity, violence, prejudice, defamation etc in advertisement.
- 6. Each team will be scored on the following criteria:
  - a. Creativity (10 marks)
  - b. Content (10 marks)
  - c. Originality (10 marks)
  - d. Overall Appeal (10 marks)

### DEBATE COMPETITION

Max. Entries: 15

**Team size: 2 Participants** 

Time Allotted: 4 minutes (2 min 'for', 2 min 'against')

#### **Rules:**

- 1. Topic of the Debate: "Exploring the Four-Day Work Week: Essential Employee Wellbeing Enhancement or Corporate Disruption?"
- 2. Students can write some notes and questions on a piece of paper & use them during the debate.
- 3. There will be a team of two speakers. One will speak 'for the motion' and other will speak 'against the motion'.
- 4. The language for the debate competition shall be English only.
- 5. Using improper/abusive & offensive language and colloquial slang will lead to disqualification.
- 6. Best speaker 'for the motion' and 'against the motion' will be rewarded seperately.
- 7. Each team will be scored on the following criteria:
  - a. Content (10 marks)
  - b. Clarity of thought (10 marks)
  - c. Oratory skills (10 marks)
  - d. Confidence (10 marks)

### **BUSINESS QUIZ**

#### Max. Entries: 15

Team size: 2 participants per team

#### **Rules:**

#### 1. ELIMINATION ROUND

- a. Each team would be given a set of question paper containing 25 MCQ's.
- b. Time limit would be 15 mins.
- c. Top scorer teams will go to the stage round 1.

#### 2. STAGE ROUND 1

- a. Each team will be asked 3 questions each.
- b. +10 points for correct answer, +5 points for answering a passed question.
- c. No negative marking.
- d. Time limit is 30 seconds to answer the question.

#### 3. STAGE ROUND 2 (AUDIO VISUAL ROUND)

- a. Each team will be asked 2 questions.
- b. +10 points for correct answer, +5 points for answering a passed question.
- c. -2 points for incorrect answer.
- d. Time limit is 30 seconds to answer the question.

#### 4. STAGE ROUND 3 (RAPID FIRE ROUND)

- a. Each team will be asked 4 questions.
- b. +10 points for correct answer
- c. -5 points for incorrect answer
- d. There will be no passing of questions.
- e. Time limit is 5 seconds for answering a question.

#### SURVIVOR STOCK TRADING

Max. Entries: No limit

Team size: 1 participant

**Time Allotted**: 3 days for trading. 10 minutes per team for presentation (including Q & A session)

#### **Rules:**

- 1. Each participant will be given a virtual account on moneybhai.com
- 2. Registration on Moneybhai will close on 2<sup>nd</sup> April 2024.
- 3. At the start of the game, virtual money will be allocated to each participant.
- 4. Virtual Trading will run for 3 working days (3<sup>rd</sup> 5<sup>th</sup> April 2024).
- 5. Stock trading will be done only on working days as per stock markets.
- 6. Each participant will get Rs 1 crore virtual cash for investment, from which it is mandatory to invest atleast 50 lakhs within span of 3 days in securities of his/her choice They can opt for cash or intra-day trading as per their choice and brokerage charged will differ according to the type of trade executed.
- 7. On the day of the event i.e. 8<sup>th</sup> April 2024, each participant must give a brief presentation of their daily trading activity i.e., screenshots of their net worth in morning, afternoon and evening respectively and track of their respective portfolio growth through graph and pie charts.
- 8. The ONE in the league with the highest net worth (value of stocks held) at the end of day 3 i.e. 5<sup>th</sup> April 2024 will be declared as winner provided that participant presents his/ her proceedings in front of the judges. In case the declared winner of the game fails to present on 8<sup>th</sup> April 2024, the next participant with the highest net worth will be declared as the winner.
