

VISIT TO HON'BLE DELHI HIGH COURT

21ST & 22ND MARCH 2024



Centre for Legal Studies at Gitarattan International Business School had organized the Academic Visit to the Hon'ble High Court of Delhi on 21st and 22nd March 2024. The visit was organized for BA LLB Semester VIII students to enhance the knowledge of their domain. A total strength of 47 students visited the High Court along with the faculty coordinator who witnessed the functioning of the High Court and observed the proceedings.

Mr. Shekhar the official of Delhi High Court instructed the students about the rules and decorum to be maintained inside the court premises. The students were provided the causelists of all the Court Rooms by the faculty coordinator and the students were sent to different court rooms in group of 4 students to observe the proceedings in the courts. The students noted the hearings, arguments and noted the orders dictated by the Hon'ble Judges. The students posed the doubts about the court proceedings which were addressed by the faculty. The students visited various courtrooms, including the Court of Chief Justice of the Delhi High Court, the other Civil and Criminal Courtrooms and the Registrar's court. This visit allowed the students to observe court proceedings firsthand and gain a deeper understanding of courtroom dynamics and procedures. Additionally, the students had the

chance to interact with Chief Librarian of Delhi High Court and to visit the Court Library where they were introduced to the extensive collection of legal resources and facilities available to legal practitioners and scholars. Additionally, the students had the opportunity to explore the newly built Auditorium, which serves as a venue for legal seminars, conferences, and other events and also visited the Mediation Centre. Overall, these interactions and visits enriched the students' learning experience and provided valuable insights into the practical aspects of the legal profession. These interactions provided valuable insights into the functioning of the court system and the resources available for legal research and education.
