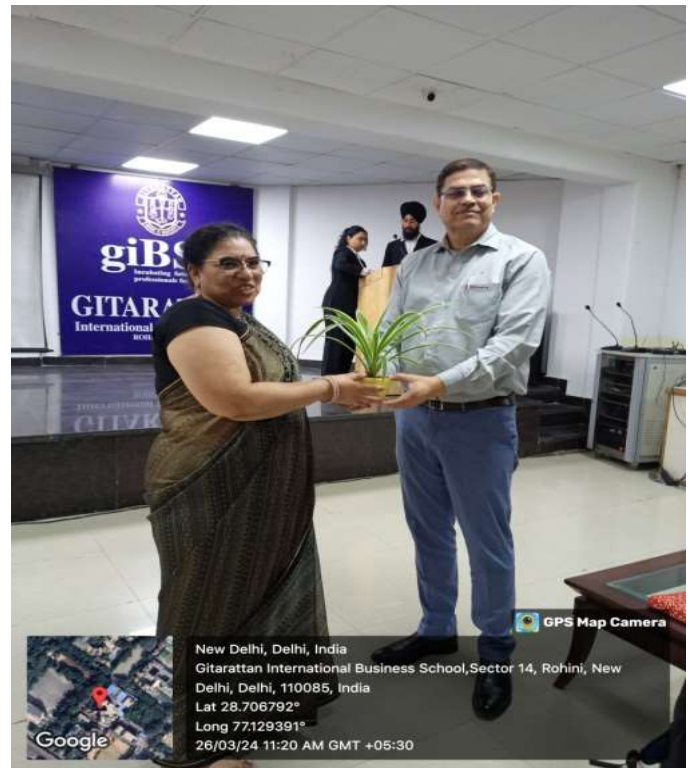


Skill Development Workshop on "USAGES OF MANUPATRA" 26TH MARCH 2024 (TUESDAY)
