25TH SEPTEMBER 2024 (WEDNESDAY)




The Legal Aid Cell of GIBS, in collaboration with the Delhi State Legal Services Authority (DLSA), conducted a Legal Awareness Session at Ekta Village Slum, Pitampura under NSS 10-day Special Residential Camp. This session aimed to educate residents on their fundamental rights, available legal resources, and procedures for accessing free legal aid. The initiative sought to empower the local community by improving their understanding of legal protections and resources available to them.

The session attracted residents, including women, youth, and elders from Ekta Village Slum. The session began with an introductory talk by Advocate Ved Garg from DLSA on the fundamental rights guaranteed to every citizen under the Indian Constitution. He explained the availability of free legal aid services for those who cannot afford legal representation. Role of DLSA and Legal Aid Clinics and were discussed in detail and Helpline Numbers of Support Centres were given to the residents.

The Session also advised the people of the local area on their ongoing cases and how they can tackle the problems which they face in daily life whether it is illegal arrest or demand of bribe by the police officers. The Legal Aid Cell and DLSA representative covered specific legal issues that are commonly faced by residents of the slum area. These included: Domestic Violence, rape, POCSO, Tenant and Landlord Rights. By discussing these issues, the Legal Aid Camp sought to cultivate awareness among the local people.

An interactive Q&A session followed the presentations, where participants were encouraged to ask questions and discuss their legal concerns. The Legal Awareness Session at Ekta Village Slum was a meaningful initiative by the Legal Aid Cell of GIBS and DLSA to empower residents with essential knowledge of their rights and legal resources. By providing access to legal information and support, the session aimed to promote justice and enhance the quality of life for economically disadvantaged individuals.
