The theme of the lecture was “The Art of Advocacy: Elevating Communication Skills for Legal Success”, delivered by Advocate Sanat Saluja, an illustrious alumnus of GIBS. He is a legal professional specializing in Intellectual Property Rights (IPR), child protection law, and commercial arbitration. Currently associated with the Network for Access to Justice and Multidisciplinary Outreach Foundation, a think tank dedicated to strengthening access to justice, Adv. Saluja has also served with prestigious institutions such as the National Commission for Protection of Child Rights (NCPCR) and GAIL (India) Ltd. His diverse experiences in dispute resolution, regulatory compliance, and child rights advocacy made his insights highly relevant and inspiring for the students.

In his session, Adv. Saluja emphasized the role of advocacy as both an art and a strategic skill essential for legal professionals. He shared practical techniques on persuasive communication, courtroom presentation, drafting precision, and ethical lawyering. Drawing upon his professional journey, he motivated students to cultivate confidence, clarity, and discipline in legal practice.

The interactive session also allowed students to engage in a Q&A round, where they sought guidance on building advocacy skills, pursuing niche areas like IPR and arbitration, and balancing professionalism with compassion in legal practice. Students found the lecture not only enriching but also motivating, as it connected classroom learning with real-world applications.

The Alumni Lecture Series thus proved to be a meaningful platform, fostering strong alumni-student connections and reinforcing GIBS’s commitment to holistic legal education. The session concluded with a formal vote of thanks to Adv. Sanat Saluja for his invaluable contribution.
