

## ROHINI DISTRICT COURT VISIT 4<sup>th</sup> OCTOBER 2025 (SATURDAY)











CLS-GIBS organized an educational and experiential court visit to the North District Legal Services Authority (DLSA), Rohini Courts, Delhi on 4th October 2025. The visit was conducted in accordance with the official communication received from the North DLSA (Ref. No. DLSA/North/Rohini/LLW/2025/311, dated 18.09.2025). This initiative formed part of the practical training and clinical legal education component for the students of Integrated B.A. LL.B. (Hons.) 1A and 1B. The purpose of this court visit was to bridge the gap between theoretical learning and practical exposure, allowing students to gain firsthand experience of judicial proceedings, courtroom ethics, and the working of legal aid systems within the Indian judiciary.

The initiative aimed to sensitize young law students to the procedural nuances of trial courts, to understand how access to justice is ensured through legal aid mechanisms, and to provide an opportunity for direct observation of how the law functions in everyday practice.

The visit commenced at the Legal Aid Defense Counsel System (LADCS) Office where the Chief LAD Counsel and officials briefed the students about the functioning, objectives, and importance of the system. Students were explained how LADCS provides legal assistance to indigent litigants and underprivileged individuals, ensuring access to justice as guaranteed under Article 39A of the Constitution of India.


Subsequently, the students were divided into six groups and directed to various courtrooms, as per the schedule assigned in the official order. Each group interacted with judicial officers including Ms. Vandana (ASJ-02), Ms. Pooja Jain (ASJ-05, POCSO), Ms. Amardeep Kaur (ACJM), Ms. Bhujali (JMFC-01), Ms. Sanya Dalal (JMFC Mahila Court-01), and Ms. Disha Singh (JMFC Mahila Court-02). The respective judges graciously allowed students to observe the proceedings in progress, which included hearing of criminal cases, examination of witnesses, framing of charges, and bail arguments.

This practical exposure helped students relate procedural law concepts from their coursework — including the Code of Criminal Procedure, Indian Evidence Act, and Indian Penal Code — to their application in actual judicial proceedings. Students noted the decorum maintained in court, the professional communication between the bench and bar, and the critical role of court staff in maintaining judicial efficiency.



Students expressed that the court visit was an invaluable experiential learning opportunity that enriched their understanding of practical law. They appreciated the effort of DLSA and the faculty in facilitating such an initiative that complements classroom instruction with real-world exposure. The experience fostered professional confidence, ethical insight, and a sense of civic responsibility among the young law aspirants.
