The Alumni Lecture Series(ALS), organized by Gitarattan International Business School (GIBS) on 23rd August 2025, it was organized as part of an ongoing initiative to bridge the gap between academic learning and the practical realities of the legal profession. The session titled “*Building a Successful Career in Law – Lessons Beyond the Lecture Hall*” aimed at providing students with insights and strategies necessary for excelling in the profession beyond theoretical knowledge. The event featured distinguished alumni who shared their experiences, challenges, and lessons that shaped their journey in the legal field.

The session was graced by **Mr. Mayank, Managing Partner and Founder, TLJ Law Offices, Alumni**, BALLB batch 2018- 2023, shared his personal journey of quitting a stable job to establish his independent practice. He posed a thought-provoking question to the audience: “*What is more fascinating—higher salary or having your name mentioned in a judgment?*” This invited students to reflect deeply on the values of passion, recognition, and long-term professional satisfaction in law. Mr. Mayank also candidly discussed the problems faced as a fresher, stressing that the initial years are challenging and demand persistence, adaptability, and humility. He highlighted that classroom learning and practical realities differ greatly, and it is through real-world practice that a law graduate truly develops into a professional. His experiences served as both a motivation and a reality check for students preparing to step into the profession.

The session successfully fulfilled its objectives and its expected outcome. The students thoroughly enjoyed the session and actively engaged with the speaker through insightful queries. The interactive nature of the event encouraged meaningful dialogue and reflection. Positive feedback was received from participants, who expressed keen interest in having more such sessions in the future, reinforcing the success of this initiative.
