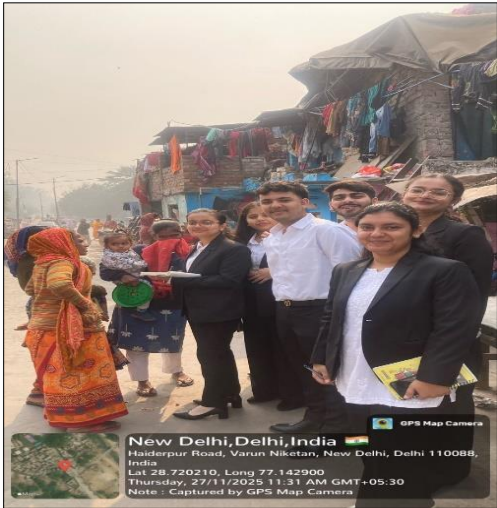


10 DAYS SPECIAL CAMP -DAY 7 & 8
LAC (LEGAL AID CLINIC)
27&28 NOVEMBER 2025 (THURSDAY & FRIDAY)



The NSS Unit of Gitarattan International Business School (GIBS), in collaboration with the **Legal Aid Cell of the college**, conducted a two-day **Legal Aid Clinic** at Ekta Camp as part of Day 8 and Day 9 of the 10 Days Camp. The aim was to identify legal issues faced by the residents and provide them accessible legal awareness and support.

On **27th November**, volunteers from both the NSS Unit and the Legal Aid Cell conducted a **door-to-door legal survey** across the lanes of Ekta Camp. The residents were asked about the **legal troubles they were facing**, such as issues related to documentation, family disputes, property matters, workplace grievances, and access to government schemes. The survey helped in understanding the real and recurring legal problems within the community.

On **28th November**, an **Awareness Camp** was organized at the same location, where an **advocate** from the Legal Aid Cell addressed the concerns collected during the survey. The advocate explained the legal remedies available, guided residents on filing complaints, and gave clarity on their rights. The community was also informed about **free legal services provided by the Government**, including the availability of Legal Aid Authorities, helplines, and support systems for economically weaker sections.

The residents actively participated and asked questions about their issues, making the session interactive and impactful. The two-day initiative helped bridge the gap between legal awareness and community access to justice.
