1. ELIGIBILITY / PARTICIPATION IN COUNSELLING

First Round: Eligible candidates already registered with the designated agency/GGSIPU and not already admitted shall be considered for admission in the First Round strictly on merit and subject to fulfilment of the applicable eligibility conditions.

Subsequent Round: In case seats remain vacant after the First Round, fresh eligible candidates who were unable to register earlier with the designated agency and have not been admitted so far shall be considered against the remaining vacancies in accordance with the procedure and schedule prescribed by GGSIPU.

Programme-wise eligibility and merit criteria shall be governed by the applicable GGSIPU Admission Brochures for Academic Session 2026–27, applicable statutory-body norms and directions/orders of GGSIPU/DHE/competent authorities.

Programme-wise Eligibility Criteria:

MBA	Candidates must have a 3 year or more Bachelor's degree in any discipline with at least 50% marks from a recognized university. Applicable Entrance Examination: CAT-2025, CMAT-2025, CET 2026 & CUETPG 2026
LLM	Candidates must have an LL.B degree with not less than 55% marks as per as per GGSIPU guidelines. Applicable Entrance Examination: CLAT-PG 2026, CUETPG 2026
BBA & BBA-MBA(Integrated)	Candidates must have passed in 12th of 10+2 with a minimum of 50% marks and must also have passed English as per GGSIPU guidelines. Applicable Entrance Examination: GGSIPU CET 2026, CUETUG 2026
BCA	Pass in 12th Class of 10+2 of CBSE or equivalent with a minimum of 50% marks in aggregate with pass in English (core or elective or functional). Mathematics or Computer Science / or any other subject related to Computer Science. Applicable Entrance Examination: GGSIPU CET 2026, CUETUG 2026
Integrated-BALLB(Hons.)	Pass in 12th Class of 10+2 of CBSE or equivalent with a minimum of 50% marks in aggregate with pass in English (core or elective or functional). Applicable Entrance Examination: CLATUG-2025, CUETUG 2026

Applications may be submitted by **registered as well as fresh eligible candidates**. Consideration for admission shall, however, be strictly in accordance with the **round-wise procedure prescribed by GGSIPU**.

2. Mere submission of an application or inclusion of a candidate's name in a merit list **does not confer any right to admission**.
3. Candidates shall be required to produce the prescribed **original documents/certificates along with requisite photocopies** at the time of counselling/admission.
4. Candidates must report for counselling as per the **date, time and reporting schedule notified by the Institute**.
5. Candidates are advised to regularly visit the Institute website for **updated vacancy position, eligibility criteria, merit lists, counselling/reporting schedule and other admission-related updates**.
6. Admissions shall be governed by the applicable **GGSIU Admission Brochures 2026-27** and applicable orders/directions of **GGSIU, DHE, DTTE and the concerned statutory body/competent authority**, as the case may be.
7. The applicable **last date for admission prescribed by the concerned statutory body/competent authority and/or GGSIPU/DHE/DTTE shall be strictly adhered to**.
